Reflecting Together

"WHAT TROUBLES YOU?"

Back in August, we began preparing the devotional you'll be given for Lent. This year's theme is: "When Trouble Comes...." Out of curiosity, I wanted to know your thoughts. So I asked: What problems do you think about?

Where do you see suffering? Who's struggling? I sent out about 50 emails; most of you responded.

Here is some of what you sent me.....

I'm concerned about the behaviors of some people I work with: Loud outbursts, disrespect, bullying. What is the root cause? It is related to poverty or alcohol or drug use or behavior they see with their parents?

I'm concerned about the financial needs of our helping agencies (TREP, Hope House, Habitat for Humanity, Domestic Violence Center, Church Camps, Painting Pathways, etc.)

I'm am troubled by the lying we hear on television. Slander and defamation of character are common, and have ruined people's lives and reputations.

What keeps me awake is how thoughtless and uncaring this world has become. Some people are just hatefully cruel.

I'm worried about our poor. We need to help them, but they also need to help themselves.

It makes me sad to see so much gun violence. I see people suffering from substance abuse, mental health, poverty, negligence. I see how adults and children are more glued to their phones than the people around them. Our phones have become modern day idols. I lost two babies. It still hurts. Arrogant people bother me. Disabled people are mistreated. I had a near-death experience. I have children who have genetic conditions. I know people who are alcoholics. It troubles me to observe the trauma that has occurred to others. The stigma of mental health and drug abuse is more destructive than the actual trauma. People with depression have courage.

I am saddened by the cruel judgements human beings have against their fellow human beings. Most are doing their very best to survive. We could drive ourselves crazy with the politics of the world. I think we need to be more sensitive to struggles of people who are our neighbors. The suffering of our grandson's suicide is more than I can wrap my head around. We have no comprehension of how strong addictions are. He was stressed by an addiction he could not conquer. Suffering begets suffering. People can't talk about their pain. Everyone is struggling and grieving at some level. What troubles you? The opioid epidemic. Our government leaders who bully rather than lead. Our inability to talk about some sort of gun control. I have one son who is 43 and has not found himself in any way that provides stability. I see too much white supremacy. I am troubled by scapegoating of immigrants. Is it wrong to want to feed your family? What are we scared of?

Health care is expensive. I see some who can't pay for medical bills. Some people have no space for God in their lives. I see people struggling to keep their heads above water. Some just don't have enough, and of course some make poor choices but don't we all. Not many seem to enjoy the life God has given us to live. I worry about our youth. The media gives them the wrong impression of the good life. People are lonely. Social media is a sign of our loneliness. We want to appear connected but you're not connected with just words on a screen. I just wish my children would believe and trust in God. Our youth are struggling with angry personalities. I can't imagine what they feel from their parents or their friends.

I trust we can persevere with each other through our trust in our Lord Jesus Christ.

Choosing just one.... from Pastor Colie

A few months ago, I wrote about the “Pastor Q+A” Sunday that we had this summer. Today, I’d like to focus on another question that was written that Sunday but not addressed within the service: “If you could preach on ONE Bible story every week, which would you choose? And why?”

I thought this at first would be a simple question, but the more I think about it, the more complicated it gets. At first, I was thinking about trying to name my favorite Bible stories... Some of my favorite characters are smaller ones: Shiphra and Puah, the midwives at the beginning of the Exodus story (see Exodus 1:6-21), are amazingly brave (not to mention totally hilarious); Queen Vashti (Esther 1:1-21) is fiercely self-confident and self-respecting. The story of Peter and Cornelius (Acts 10:1-11:18) is one of my faves, the way that Peter and his friends seem baffled by God’s movement among the Gentiles (scandal!), but then decide “Who are we to try to stop God?” But perhaps even these people who I love to think about, the stories that are my favorites to tell, I would preach on once or twice or three times, but then feel a little tapped out on how much could be said about them.

I thought about the story of Moses.... But then I thought, like the “story of Jesus”, that is probably too much to qualify as “one story” as intended in the question. 😊

Since we’re approaching Christmas, I thought about the stories of Jesus’s birth (Matthew 1-2 and Luke 1-2), which both have a lot to say about God, faith, human fear, hope, love, and so many other themes of faith that speak so well to us and the world we live in, even two thousand years later. I thought too about the Easter stories – Jesus and Mary Magdalene (John 20), Jesus on the beach with the disciples (John 21), Jesus and the disciples on the road to Emmaus (Luke 24) – stories of resurrection, about how God takes situations that seem bleak and empty and dead and brings hope and love and life back again. These are stories that make us who we are as Christians, as ones who follow the Christ, and many of the sermons I preach reference or point back to the resurrection stories. Those certainly could be possibilities if I had to choose just one.

And then I thought of something else..... that Jesus himself was a master storyteller. And so, if I had to choose just one story, maybe I would choose one of the stories that Jesus himself told. Jesus often taught in the form of Parables – simple stories that use every day life to illustrate a spiritual or moral lesson. Or, at least, they *seem* simple.... What makes parables so rich is that there is so much there. So many different details to look at, so many different angles to examine. What I’ve learned over the years is that there is no one right answer to what a parable teaches or what it means. Faithful people all over the world often come to different conclusions, depending on their life experience and understanding of the world.

If I chose just one parable, I would choose the Prodigal Son (Luke 15:11-32). First, there are several different characters to focus on, the younger brother, the older brother, and their father. Each can teach us a lot about who we are and who God is and how we might try to live faithfully. Second, I’ve learned recently about how you view the primary problem or sin in this story depends on your perspective. The Bible scholar Mark Allen Powell has studied this in several cultures – In the US, we nearly always identify the sin as greed or wastefulness on the part of the younger brother, the “prodigal” one. Bible students in Russia, however, overwhelmingly identify the problem of the story as the famine (did you know that a famine struck? Luke 15:14), and the son’s sin as trying to be self-sufficient. Seminary students in Tanzania recognize something else as the primary sin in the story: the wider community’s lack of response to the son’s need (Luke 15:16).* No one of these answers is THE right answer – they all are. I think that’s why Jesus spoke in parables --- to get us to think and to struggle, to learn from one another by talking together.

So if I were to choose just one, perhaps that is what I would choose: Luke 15:11-32. But if you ask me again in a few weeks, maybe I’ll have a different answer..... This question is hard!

ADVENT OFFERING: WHAT IF? FOUNDATION



Tell me about the What If? Foundation.....

The *What If Foundation* was created in 2000 by Margaret Trost, a young mother and business owner, and Father Gerard Jean-Juste, a celebrated Haitian human rights activist. Margaret met Father Jeri and was inspired by his commitment to social justice. Margaret wrote the book *On That Day, Everybody Ate* which describes the birth of the *What If Foundation*.

Father Jeri had a vision. He told Margaret “First we feed the children, we keep them alive. Then we focus on education.” We have been working with the Ti Plas Kazo community to fulfill Father Jeri’s vision ever since. “*Piti piti na rive*” is Margaret’s favorite Creole saying. It means “little by little, we will arrive.” The *What If Foundation* was founded on the belief that food security and education are critical to breaking the cycle of poverty and that every act of service makes a difference.

Why does Grace Congregational Church Promote this offering?

Some of us are concerned about self-indulgent spending during the season of Christmas. A gift to the What If? Foundation is an expression of our faith in Jesus Christ and his love for the poor. We learned about the What If? Foundation through the Rev. Fred Trost, a former Conference Minister in Wisconsin whose daughter is Margaret (above). The singer, song writer and pastor, Bryan Sirchio, is on the Board for the What If? Foundation. He leads ‘reverse mission trips’ to Haiti.

What Impact has the What If? Foundation had upon poverty in Haiti?

Over nineteen years, the What If? Foundation has helped provide more than 5 million meals to hungry children and families. The food program is managed by local residents. The food is purchased from local farmers. The What If? Foundation has funded thousands of scholarships, and more recently helped build the Fr. Jeri School which has become a beacon of hope

Can you tell me more about the What If? Foundation?

Two members of our church have personally observed the work of the church in Haiti. Do you have questions? Pose them to Betty Becker and Don DeBruyn. On November 24, the Rev. Fred Trost is going to speak at our Sunday morning worship services. We will invite him to our adult study class. Read Margaret Trost’s book, “On the Day that Everyone Ate.”

The simple mission of the What If? Foundation is to feed and educate impoverished children in Port-au-Prince, Haiti, providing hope and opportunity for a brighter future.

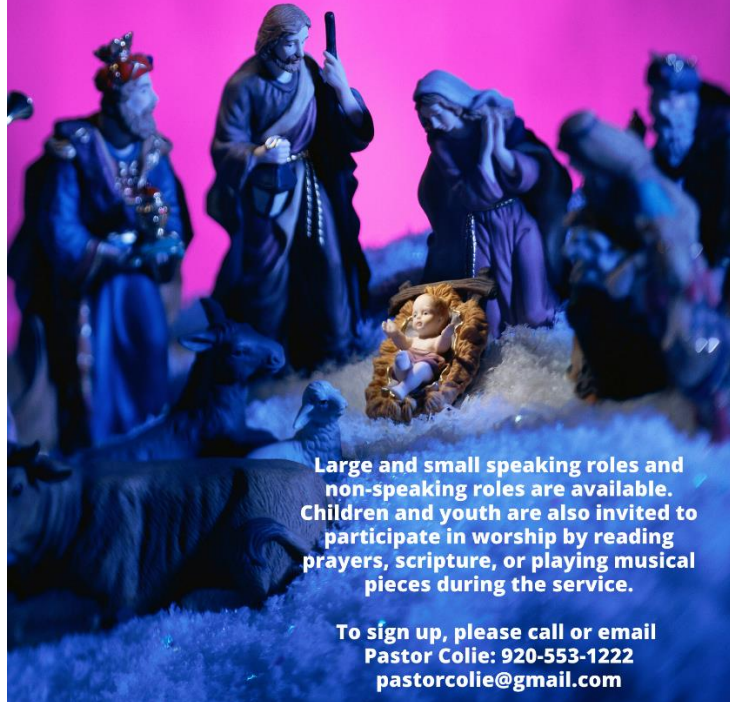

A note from your Trustees:

Thank you for caring for the financial well-being of our church. We did something this fall we've not done before. In advance of year's end, we projected a financial short-fall that we thought you'd want to know about. 35 of you have contributed \$3700 towards that deficit. We are 1/3 of the way towards our goal. On our part, we (the Trustees) are working on health insurance options that will better control this quarterly expense. On your part, we hope that next

NEW CONSTITUTION AND BYLAWS ADOPTED

In January 2018, leaders of our church boards and our pastors voiced a need to review and revise our church constitution, which had been adopted in 1962. Terminology and language needed updating, new committees and positions had been created since then, and some of our current procedures did not strictly match descriptions in the constitution. The Cabinet voted to appoint a committee to this task, and approved the membership of the committee in April 2018. Starting last May, the committee began a thorough review and rewrite of the constitution and broke out a set of bylaws. They presented their work at an informational session on September 15 and incorporated several suggestions into their final draft, which was made available to members by September 27. A special congregational meeting was called for October 27 to decide whether to adopt the proposed new constitution and bylaws. Around 40 members attended that meeting and all voted in favor of adopting them.

The new constitution and bylaws were sent by email to all members who received the November church newsletter, along with a letter explaining changes from the previous constitution. Paper copies are also available from the church office on request. If you serve as an officer or are on a Board or committee, please review the sections that apply to your area of service. And if you want to know more about a position for which you are asked to serve, you can find a description in these documents.

Thank you to members of the Constitution Committee and to all who provided input to this effort.

HIGHLIGHTS FROM THE CABINET and FROM OUR MODERATOR

As of November 19, our Treasurer reports that \$3900 has been received in response to the special appeal from our Trustees to help close the shortfall expected in receipts to meet our 2019 budget. If you are able, please consider contributing to this effort, as we still are anticipating a shortfall of around \$4000. And we need everyone who can to fulfill their pledge for this calendar year. Our Trustees have kept expenses under their control within budget, with the exception being snow removal for 2019.

In response to the Stewardship presentations, around 100 pledge cards for 2020 have been returned to date. Our Trustees need an estimate of pledge income to develop the budget for next year, so please return your completed pledge card as soon as possible.

Our newly adopted bylaws (article 5.1) state, "Grace Congregational United Church of Christ welcomes into membership all persons of every race, culture, age, gender identity, sexual orientation, ability, economic status and family structure." As we seek to be more welcoming to the diverse members of our communities, our Open and Affirming Task Force is discussing ways to better communicate and practice this. If you have ideas and wish to participate in this conversation, consider attending one of their meetings, which are listed in the monthly church calendar.

We have also learned that the new language in our bylaws qualifies us to be considered "Open and Affirming" by the United Church of Christ and to be listed with other such congregations on their website.

Renee Anderson from our congregation serves on the Board of Directors of the Two Rivers Mishicot Ecumenical Pantry and informs us that the Pantry wants to establish a Board of Advisors to help them with financial planning for sustaining their operations into the future.
